In Item 5, both the plans and participants are counted for purposes of Item 5.D. but the participant accounts and related assets are reflected in 5.F.(2) because the plan assets are beneficially owned on behalf of the participant. There are 31,025 participants that direct their own investments, and those persons are counted towards the total client counts in Item 5.D(a), however their assets are not counted towards regulatory assets under management in Item 5.F(2)(c).
